CODE OF CONDUCT

1. will behave in a manner befitting a New Zealand representative & place myself under the control of the Team Manager & his/her delegates (if any)
2. shall assist where possible with reasonable promotional exercises necessary to fund the team & not to act in a manner counterproductive to those efforts
3. will, if requested, provide medical records, certificates & allow examinations necessary to confirm my fitness & eligibility for the team
4. as an athlete, submit to a drug test if selected by the Competition Jury , Technical Officer or recognized World Anti-Doping Agency (WADA) approved doping organisation such as Drugfree Sport NZ (DFS)
5. will exclude the NZPF from liability for damage to person or property & to indemnify the NZPF against liability in respect to my participation in NZPF or the International Powerlifting Federation (IPF) sanctioned events
6. shall not make any comment to the media without authority of the Team Manager or governing NZPF authority

ATHLETE ACKNOWLEDGEMENT & AGREEMENT CONCERNING SPORTS ANTI-DOPING RULES & THE PROVISION OF PERSONAL INFORMATION

1. as member of the NZPF may only participate in NZPF or IPF sanctioned events
2. acknowledge should I breach this code the NZPF reserves the right to take any disciplinary action it considers appropriate
3. have read the drug free information at www.drugfreesport.org.nz
4. may have my name passed to DFS for drug testing planning, registered testing pool &/or whereabouts selection
5. am bound by the anti-doping policy of the NZPF, set out in the Sports Anti-Doping Rules (2007) (SADR), as amended from time to time
6. understand that under the SADR, DFS is authorised to carry out doping control, to investigate anti-doping rule violations, & present evidence in support of anti-doping violations before the Sports Tribunal (the Tribunal). I recognise & accept the authority & responsibility of DFS under the SADR
7. agree that all matters or disputes arising in any way from the application of the SADR will be referred to the Tribunal & that any appeal from a decision of the Tribunal will be to the Court of Arbitration for Sport, as provided for by the SADR
8. will provide personal information, including whereabouts information, to NZPF & DFS as requested from time to time, so that NZPF & DFS can carry out their responsibilities under the SADR & acknowledge that failure to provide whereabouts information may result in an anti-doping rule violation being committed under the SADR
9. understand the NZPF & DFS may disclose personal information provided by me to anti-doping organisations & other third parties for the purposes of carrying out their obligations under the SADR &/or the WADA Code
10. acknowledge personal Information supplied by me will be maintained by NZPF & DFS & I am entitled to have access to that information in accordance the Privacy Act 1993
11. will remain subject to the SADR until such time as I cease to be a member of the NZPF
